For the past 12 years, The Dragon Foundation has been providing quality programmes and activities for young Chinese leaders from around the world, as they learn more about how they can contribute to their own locations and to China.

This mission, I believe, has a particular relevance when we consider how small our world has become. We are now connected instantaneously through technology and social media, and no longer are there barriers of geography or time to excuse us from knowing about each other and working together for good. The Foundation has always emphasised the imperative for young people to be cognisant of how interlinked we all are and to develop the tools and abilities to analyse events from a global, rather than simply a local, perspective.

About The Dragon Foundation

2000 was not only the beginning of the new millennium, it was also the Year of the Dragon in the Chinese calendar. To commemorate these auspicious events, The Hong Kong Federation of Youth Groups, the Home Affairs Bureau of the Hong Kong Special Administrative Region (HKSAR) Government and The All-China Youth Federation co-organised the *Dragon at the Great Wall – Commemorating the New Millennium: a Vision for Youth*.

This special project included a youth conference, *Meeting the Challenges of the New Millennium*, which discussed issues under the theme of was *Visualising the Trends of Global Development and the Challenges of the 21st Century*. Held at the Great Hall of the People in Beijing and followed by more than three thousand Chinese youth from across the globe, the entire event culminated in raising a 10,000-foot-long dragon at the Great Wall which successfully broke the current Guinness World Record for the longest dragon dance.

Following this successful event, and with community support and encouragement, The Dragon Foundation was then set up, taking forward the aims manifested by the *Dragon at the Great Wall*. The Foundation was established in Hong Kong and inaugurated on 12 February 2000. The Honourable Tung Chee-hwa, the then Chief Executive of HKSAR and the Honourable Elsie Leung, then Chief Justice of HKSAR, officiated at the Inaugural Ceremony.

The Foundation was incorporated under the Companies Ordinance and registered as a non-profit, charitable organisation. Its fundamental objectives are to develop leadership skills and nurture innovative and creative talent among ethnic Chinese youth around the world, while encouraging and facilitating exchange networks amongst them. The Foundation also nurtures a spirit of service and civic responsibility in the community. It recognises the outstanding achievements of youth in various professions. The Foundation's Board of Directors includes representatives of The Hong Kong Federation of Youth Groups, the HKSAR Government, and prominent leaders from various sectors of the community. The Foundation's Secretariat is administered by The Hong Kong Federation of Youth Groups.

Vision

To facilitate networks among Chinese youth worldwide, to promote Chinese culture and heritage, and instil the spirit of service and responsibility.

- to establish an exchange network among Chinese youth

Administrative Review

The Secretariat

In April 2012, Mr. Stanley To succeeded Mr. Tang Wai-hung as Secretary-General with the same commitment to continue the work of the Foundation, including making day-to-day operations more efficient.

Financial Results

The audited financial statements of the Foundation for the financial year 2011/12was prepared by auditors, Li, Tang, Chen & Co., and attached herewith. The accounts show a total revenues of HK\$2,881,153 against total operating expenses of HK\$5,547,515, resulting in an expenditure excess of HK\$2,666,362. This balance will be transferred to the Accumulated Fund.

The total reserves of the Foundation as at 31st March 2012 were HK\$27,652,376.

Highlights of the Year

1. Dragon 100 Young Chinese Leaders Forum 2011

Since 2002, The Dragon Foundation has been organising the Dragon 100 Young Chinese Leaders Forum to provide a platform for young people to meet and explore issues of Chinese culture, heritage and tradition, so as to enhance their Chinese identity. The Forum affords these young dragons the opportunity to meet together, exchanging ideas and experiences, while also being able to travel to Mainland China, Taiwan, Macau and Hong Kong.

The Forum's theme in 2011 was "Caring about the Poor · Today and Tomorrow" and held from 24 July to 1 August 2011. The event comprised a three-day stay in Hong Kong and a six-day study tour to Taiwan. The 100 participants, aged between 18 and 35, represented 18 countries and regions around the world. Each has shown leadership skills, academic excellence and a commitment to the community. They were selected from nominations made by universities, institutions, corporations and organisations worldwide. The selection panel was comprised of three Directors of the Foundation: led by Mr. David Lan Hong-tsung, GBS, ISO, JP, Mrs. Rita Liu Tong Wei-oi, SBS and Mr. Samuel Ching Kwok-ho.

Because this year's Forum was held in conjunction with the Dragon Series of The Hong Kong Federation of Youth Groups (HKFYG), the 100 delegates joined together with 400 participants of the Federation and World Vision Hong Kong.

The Delegation Leader to Taiwan was the Chairman of the Dragon Foundation's Board of Directors, The Hon. Sir T.L. Yang, GBM. He was assisted by Foundation Directors, Dr. Rosanna Wong Yick-ming, DBE, JP, and Ms. Shelley Lee Lai-kuen, GBS, OBE, JP, as Deputy Delegation Leaders.

The Forum was honoured to have Dr. the Hon. York Chow Yat-ngok, GBS, JP, Acting Chief Secretary for Administration, HKSAR Government and Mr. Wang Zhimin, Deputy Director of the Liaison Office of the Central People's Government in HKSAR, as Guests of Honour for the Commissioning Ceremony.

The end of the Forum did not end with the trip; the friendships and connections continue through the Foundation's Alumni Associations: the DragonNation and Envision Hong Kong, further strengthening the bonds of all the participants so they can work together in the future.









The highlight of the trip included community service at Majia Farm, where delegates did simple building work, cleaning and farming, paid visits to the elderly single people and engaged with over 100 indigenous children. Delegates also took part in the "30 Hour Famine" organised by World Vision Taiwan. By fasting for nine hours, they could better understand issues of hunger and the plight of the poor. This helped them reflect on how to reduce poverty-related social problems through their individual efforts when they returned to their own cities. In the "Hero Rally" at the "30 Hour Famine", delegates also performed a dragon dance. With singing and rhythmic hand-clapping, a 210 metre dragon was raised, symbolic of the energy and creativity, the solidarity and compassion of the descendants of dragon.











Eminent speakers included Dr. Law Chi-kwong, SBS, JP, Associate Professor of The University of Hong Kong, Dr. Thomas Chan Sze-tong, Honorary President, World Vision International – China Office, Prof. Stephen Cheung Yan-leung, BBS, JP, Dean of School of Business and Professor (Chair) of Finance, Hong Kong Baptist University, and Prof. Kat Wang Yeong-Tsyr, Director of Graduate Institute of Social Work, National Taiwan Normal University. They all shared insights on poverty issues and possible ways to alleviate the problems.





The delegates also met students from National Taiwan University, participating in a cultural performance and exchanging ideas while finding out about life in Taiwan. Overseas participants said this helped them understand Chinese culture and see themselves more clearly as ethnically Chinese.







2. Global Citizenship Programme 2011

This year, the Victor and William Fung Foundation Limited began its sponsorship of the Global Citizenship Programme, a commitment they will continue for the next three years.

In 2011, the theme was "Sustainable Development Opportunity and Challenges: Global, Regional & Local Levers for Migration Issues". The participants were nominated by their universities in Hong Kong and interviews were held in front of a Selection Panel which comprised Mr. Chan Kai-ming, Secretary General of Hong Kong Red Cross, Dr. Francis Cheung Wing-ming, Former Secretary General of Hong Kong Examinations and Assessment Authority and Ms. Junia Ho Suk-yin, JP, Member of Programme and Fund Raising Committee Member of the Foundation.



With the rich experience gained in Thailand in 2009, the Foundation decided to continue exploring this beautiful country. A group of 30 outstanding university students were selected for a programme in Bangkok, regional headquarters of many UN agencies and international organisations. The programme consisted of a two day of orientation and training in Hong Kong and a week of learning in Bangkok.

Dr. Sooksripaisarnaki Poomintr, a former delegate of Dragon 100 and now Assistant Professor of the School of Law in the City University of Hong Kong, gave an "Introduction to Thailand" to the delegates and in the pre-departure training, Ms. Gloria Ko, Head of Hong Kong Office of International Organisation of Migration, spoke on "Global trends and impacts on migration and migration management".

During the Commissioning Ceremony held on 15 June, The Hon. Sir T.L. Yang, GBM, Chairman of The Dragon Foundation, Ms Jenny Ann Chan of the Victor and William Fung Foundation Limited, Ms Maria Luk, Acting Director of Institute of International Education and representatives from local universities also attended and joined the small group discussions.



The delegation was in Thailand from 19 to 25 June with Ms. Junia Ho Suk-yin, JP, Member of Programme and Fund Raising Committee of The Dragon Foundation, as Delegation Leader. At the opening ceremony in Bangkok, Mr. Alex Mavro, Member of Chair-Corporate Social Responsibility Committee, The American Chamber of Commence in Thailand, delivered the keynote address on "Citizen's Social Responsibilities".



Delegates had the chance to visit the Sampeng and China Town Shrimp Factory where most employers are immigrants, as well as the Thai Union Migrant Community and the Population and Community Development Association (PDA).

Delegates also worked in teams on a study project to develop critical awareness of migrant issues. At the end of the programme, each of the teams presented their project ideas, research findings and recommendations to a panel of experts. We invited Ms. Julia Kallstrom and Mr. Daniel Woods from the International Organisation of Migration, Dr. Kitti Prasirtsuk, Assistant Professor, Faculty of Political Science, Thammasat University and Dr. Chalintorn N. Burian, Regional Director, Southeast Asia, Institute of International Organisation, as presentation jurors.





To further consolidate delegates' knowledge acquired during the weeklong programme in Bangkok, a report back session was held on 7 July 2011.





Delegates shared in groups their inspirations, experiences and memories during the week in Bangkok. Mr. KM Wong, Director of the Victor and William Fung Foundation Limited, Dr. Rosanna Wong, DBE, JP, Mr. David Lan, GBS, ISO, JP, and Ms. Shelley Lee, GBS, OBE, JP, Director of The Dragon Foundation, Ms. Junia Ho, Delegation Leader, Ms Maria Luk, Acting Director of Institute of International Education, representatives from local Universities and some previous programme participants, also joined the session.



3. Lecture Series for Youth Leaders

Since 2000, the Foundation has been inviting renowned individuals to share their experience and expertise in the "Lecture Series for Youth Leaders". This year we were honored to have Mr. Li Ching and Mr. Ko Lai-chak, 2004 Athens Olympic Silver medal winners in Men's Doubles Table Tennis on 20 May 2011, at the Lions College to share their journey as sportsmen to around 200 secondary students.



4. Golf Tournament at Mission Hills Golf Club 2011

With the generous support of Mr. Tenniel Chu, Executive Director of Mission Hills Golf Club, Member of the Programme and Fund Raising Committee, the Foundation held its third Golf Tournament on 15 April 2011. Over 100 well-known people and philanthropists were invited and over HK\$660,000 were raised which will go towards leadership training programmes.


5. "1911" Charity Premiere

6. Sponsoring the production of DVD on "A Century of China Multimedia Production" (「百年中國」大型多媒體製作)

In commemorating the 1911 Revolution, HKFYG had launched a 2011 China Week on "A Century of China since the 1911 Revolution" (2011 中國歷史文化周 — 從辛亥革命看百年中國) in July 2011.

A series of events were held including several shows on A Century of China Multimedia Production, in which the responses from the participants have been very positive and encouraging. In order to let more young people acquire a better understanding on the historic development of China over the past decade, the Foundation sponsored the production of 2,500 copies of DVD (with a booklet inside the DVD box) on the Multi-media Production and were distributed to all local schools, universities, government departments, and related organisations free of charge.



7. "Discover Design 2011" organised by the Hong Kong Design Centre (HKDC)

The Dragon Foundation made a sponsorship for "Discover Design 2011" which has total of over 5,000 participants in the summer youth and concurrent programme.

The HKDC has been actively organising events and activities that provide senior secondary students an opportunity to experience what education and work are like in the design and creative professions. Over the past three years, "Discover Design" offered studio work, design workshops, mini projects, meet-the-designers session and visits to students in Hong Kong. "Discover Design 2011" was held from 11 to 29 July 2011. With full support from Hong Kong Disneyland, themed "Discover the Magical Moments", the programme offered students an opportunity to explore the design elements in the world-renowned theme park, so as to inspire and stimulate the students on how to apply design and design concepts in their everyday life. To enrich the programme content, a cultural and knowledge exchange platform has also been provided to regional and local students.

8. Alumi Association

8.1 DragoNation

To maintain firm connections between past participants around the world, the Alumni Association of The Dragon Foundation, "DragoNation", was launched in 2008. The Association's Executive Committee's seven enthusiastic young leaders arranged the following activities during the year: a meeting with Dr. Vincent Lo, Director of The Dragon Foundation and Chairman of Shui On Holdings Ltd., on 3 September 2011; a meeting with Mr. Samuel Ching Kwok-ho, Director of The Dragon Foundation and Partner of King & Company, Solicitors & Nataries, on 29 November 2011; a meeting with Mr. Chong Chan-yau, former Executive Director of Oxfam Hong Kong; and a tour to Taipei World Design Expo in late October 2011.









8.2 Envision Hong Kong

In 2009, active members of DragoNation set up a new organisation, "Envision Hong Kong" which aims to support sustainable development in the community by engaging young professionals in youth development activities. A website was created to communicate with members all over the world (www.envisionhk.org). A large scale community-based mentorship project the "Youth Envisioning Scheme (YES)" was launched at local secondary schools with 88 secondary students from 12 local schools, 44 local mentors and 22 overseas mentors from over 25 countries participating. A series of leadership training workshops, community-based projects and a youth summit took place between June and September 2011.

8.3 Appointment to the HKFYG Youth Service Advisory Committee

Mr. Alan Koo Hoi-lun, Ms. Jenny Tao Chun-ni, Mr. Clive Lee Ka-lun and Ms. Angelica Leung Yiu-wen, members of DragoNation and Envision Hong Kong, were nominated to the HKFYG Youth Service Advisory Committee. This is a Committee which provides young people a platform to air their views, while also honing their leadership potential. All four will serve on the Committee until September 2012.
