About The Dragon Foundation

The year 2000 was celebrated both as the start of the new millennium, as well as the Year of the Dragon in Chinese culture. To commemorate this auspicious date, The Hong Kong Federation of Youth Groups, the Home Affairs Bureau of the Hong Kong Special Administrative Region (HKSAR) Government and the All-China Youth Federation co-organized a project entitled, "Dragon at the Great Wall – Commemorating the New Millennium: a Vision for Youth".

What the project entailed was a Youth Conference on **Meeting the Challenges of the New Millennium**. The main theme of the Conference was *Visualizing the Trends of Global Development and the Challenges of the 21st Century* and was held at the Great Hall of the People in Beijing. The Conference was followed by more than three thousand Chinese youth from across the globe raising a 10,000-foot-long dragon on the Great Wall, successfully breaking the current Guinness World Record for the longest dragon dance.

With community support and encouragement, The Dragon Foundation was set up and takes forward the aims manifested by the "Dragon at the Great Wall". The Foundation was established in Hong Kong and inaugurated on 12 February 2000. The Honourable Tung Chee-hwa, the-then Chief Executive of HKSAR and the Honourable Elsie Leung, the then Chief Justice of HKSAR, officiated at the Inaugural Ceremony.

The Foundation was incorporated under the Companies Ordinance and registered as a non-profit making, charitable organization. The fundamental objectives of the Foundation are to develop leadership skills and nurture the innovative and creative talents of ethnically Chinese youth from around the world, while also encouraging and facilitating the creation of exchange networks amongst them. The Foundation also nurtures a spirit of service and civic responsibility towards the community. It furthermore recognises the outstanding achievements of youth in various professions. A Board of Directors for the Foundation was set up, which includes representatives of The Hong Kong Federation of Youth Groups and the HKSAR Government, along with prominent leaders from various sectors of the community. The Foundation's Secretariat is administered by The Hong Kong Federation of Youth Groups.

Vision

To facilitate networks among Chinese youth worldwide; to promote Chinese culture and heritage and to instil in them a spirit of service and responsibility towards the communities in which they live.

Objectives

The Dragon Foundation aims:

- to develop leadership skills
- to establish an exchange network among Chinese youth
- to facilitate the development of innovative potential
- to provide opportunities and ways to participate in serving the community
- to honour outstanding Chinese youth in various professions

Administrative Review

The Secretariat

Manpower at the Secretariat remained stable this year, with a simple structure and efficient day-to-day operations.

Financial Results

The audited financial statements of the Foundation for the financial year 2008/2009 showed a total revenue of HK\$ 9,205,760 against a total operating expense of HK\$ 4,398,363, resulting in an excess of revenues over expenses of HK\$4,807,397. The balance will be transferred to the Accumulated Fund. The total reserves of the Foundation as at 31st March 2009 stood at HK\$29,899,129.

Details of income and expenditure can be found in the Auditors' Report and Accounts.

Highlights of the Year

1. Dragon 100 Young Chinese Leaders Forum 2008

The Dragon 100 Young Chinese Leaders Forum is a flagship programme of the Foundation since 2002, bringing together 100 young leaders to reflect upon a specific theme, while also having the opportunity for travel, exchange and exposures.

The theme for 2008 was "Thirty Years of Reform and Opening-up on the Mainland China", focusing on the rapid economic development of the recent China.

The participants were selected from nominations of local and overseas universities, organizations and businesses in 15 countries and places. The Selection Panel was led by Foundation Director, Mr. David Lan Hong-tsung. Members include Dr. Cherry Leung Yuen-yee, Honorary Consultant, Federation of Hong Kong GuangDong Community Organizations, and Mr. Stanley Yeung Chee-tat, Member of Programme and Fund Raising Committee of the Foundation. In August 2008, the Dragon 100 delegation went on a nine-day tour of Hong Kong and the Pearl River Delta Region with Sir T.L. Yang as its Delegation Leader, and Delegation Advisors including Dr. Rosanna Wong Yick-ming, Ms. Shelley Lee Lai-kuen, and Mr. David Lan Hong-tsung.

Due to adverse weather conditions, the Opening Ceremony had to be cancelled. In spite of this, the Forum was well supported by Professor the Honourable K.C. Chan, SBS, JP, Secretary for Financial Services and the Treasury as the invited Guest of Honour. The delegation had the privilege to have Professor Lau Pui-king, JP, Associate Professor, School of Accounting and Finance, The Hong Kong Polytechnic University to speak on the topic of "The Open Door Policy of China and its Impact to the World".



During the Mainland programme, the delegation visited sites of economic significance to the rapid development of the Pearl River Delta Region which included the Yantian International Container Terminals, New Island Printing Holdings Limited, Esquel Group, and the Guangdong Shipyard International Company Limited. In Guangdong, they were honoured to meet with Ms. Wang Hongyan, Secretary of the All-China Youth Federation. They also visited the Hong Kong Economic and Trade Office in Guangdong of the HKSAR Government and met the Deputy Director, Ms. Alice Choi. In Jiangmen and Zhongshan, they were well received by government officials including Mr. Xie Rirong, Deputy Mayor of the Jiangmen Government, Mr. Huang

Yuesheng, Standing Member and Secretary-General of the Jiangmen Committee of the CPC, Mr. Benjamin Liang, Chairman of the Jiangmen Youth Federation, and Mr. Du Minqi, Chairman of the Zhongshan Committee of Communist Youth League of China and The Youth Federation of Zhongshan. Officials showed appreciation of the outstanding young Chinese leaders from around the world for synergy with their Mainland youth counterparts.



The delegation also visited cultural and historical sites, including the World Heritage Kaiping Diaolou, where history expert, Dr. Kenneth Lan, Assistant Professor of the United International College of Beijing Normal University and Hong Kong Baptist University spoke of the history and significance of the world heritage site. Also visited were the Jiangmen Overseas Chinese Museum, the Liyuan Garden, the Former Residence of Liang Qichao, and the Birds' Paradise in Xinhui.

Throughout the forum, delegates also participated in Cultural Nights and shared their own experiences with each other. Participants from the delegation, as well as their colleagues from the Mainland agreed that the exchange enabled them to understand and identify themselves more clearly as being ethnically Chinese. They also gained a more thorough understanding of recent development trends in China.



2. Global Citizenship Programme

The Global Citizenship Programme is organized to inculcate a sense of responsibility in young people while raising their awareness of global trends. It provides international exposure and training for young Chinese leaders, maximizing their capacity to create networks for sharing and mutual exchange, and encouraging dedication to the community.

The theme of the fifth Global Citizenship Programme was "Ethical Interdependence." Two groups of 30 outstanding university students were selected for the programmes related to "Ethics and International Organizations" in Geneva, or "Ethics, Creativity and Innovation" in New York. The programmes comprised two days of orientation and training in Hong Kong and a week overseas for each group. There were visits to non-governmental and international organizations in both cities and iconic centres of innovation and creativity in New York.

The Geneva Programme focused on international organizations in Europe, and the New York Programme emphasized creativity in media and entertainment as well as innovation in the urban environment in New York. Projects and other exposure also helped participants acquire information and skills expected of young leaders in a global era. There was encouraging feedback from guest speakers, participants, the media and the public about the Foundation's efforts to create and support a global network of future leaders.

Nominations were made by universities in Hong Kong and two rounds of interviews were held. Members of the final Selection Panel for the Geneva Programme were Ms. Shelley Lee, (Head Judge), Director and Vice-Chair of Programme and Fund Raising Committee of The Dragon Foundation, Ms. Winnie Yeung, Director, Legal & Corporate Affairs of Microsoft Hong Kong Limited, and Mr. Clifford Yim, General Manager and Member of the Board of Shun Hing Technology Co. Ltd. The three members of the New York Programme Selection Panel were Mrs. Fanny Law (Head Judge); Dr. Chan Man-wai, Vice President, Projects and Facilities of Hong Kong Science & Technology Parks, and Mrs. Katherine Fung-Surya, Director of Canadian Education Centre of Hong Kong.

At the Commissioning Ceremony in Hong Kong on 4th June 2008, we were honoured to have Mr. James B Cunningham, US Consul General, Hong Kong, Mr. Felipe Palacios Sureda, Acting Head of Office of the European Commission in Hong Kong and Macao as Guests of Honour and Mr. Andrew Brandler, Chairman of the Hong Kong General Chamber of Commerce as our Keynote Speaker.



At a two day pre-departure orientation in Hong Kong delegates learned about the ethics of global citizenship and the social responsibilities of being a young leader from Professor Edward Chen Kwan-yiu, GBS, CBE, JP, former Director of the Dragon Foundation, Mr. Kevin Chiu, CEO of World Vision Hong Kong and Dr Anthony Hutchinson, Director of Public Affairs Section, Consulate General of the United States of America, Hong Kong.



The first group went to Geneva, Switzerland from 6-13 June. Ms. Shelley Lee, Director of the Foundation was Delegation Leader. The delegates had the chance to visit the United States Mission to the United Nations Office, the Palais de Justice, the United Nations Offices, the Palais des Nations, the Red Cross Museum, the International Committee of Red Cross and Red Crescent Museum. At the Opening Ceremony in Geneva, Ambassador Wang Qun, Mr. Martin Glass, and Ms. Shelley Lee spoke, followed by key note addresses by Dr. Daniel Warner, Deputy to the Director of the Graduate Institute of International and Development Studies and Ms. Maria Livanos Cattaui, Former Secretary General, International Chamber of Commerce.



Dr. Warner spoke of the historical development of Geneva, and the emphasis on consensus and tolerance. Ms. Maria Livanos Cattaui shared her observation from a different angle and spoke of how commerce has become increasingly important in devising international policy.

The participants also attended lectures by Ms. Barbara Boldt, Consultant, Assistante-doctorante, Ecole Polytechnique, Mr. Jon McLin, former ILO representative, Dr. Virgina Leary, Lawyer and Advisory Board, Programme for the Study of International Organization at the University of Geneva's Graduate Institute of International Studies, Mr. Josep Bosch, Press Officer, Information and Media Relations Division, World Trade Organization, Prof. Edward Dommen, Economic Ethics Specialist, Mr. Donald Ng, Deputy Representative of Hong Kong SAR of China to the WTO. Dr. Marie-Charlotte Bouesseau, Ethics, Equity, Trade, and Human Rights, World Health Organization, Mr. Andres Olleta, Law Researcher, International Environmental Law Research Centre, International Environment House, Dr. Arthur Lyon Dahl, President, International Environment Forum, Geneva, Mr. Alexandre Favre, Programme Officer of Geneva Environment Network, Ms. Gry Tina Tinde, Special Advisor to the High Commissioner on Gender Issues, Mr. Robert Archer, Executive Director of International Council of Human Rights Policy. We also had Mr. Eddy Lee, Senior Advisor on Economic and Social Policy, International Institute for Labour Studies, ILO, and Dr. David. H. Freeman, Economist and Employment Policy Consultant and our guest speaker, Ms. Barbara Boldt as our group project presentation jurors.





The second group went to New York from 20-27 June and was led by Mrs. Fanny Law. At the Opening Ceremony, welcoming remarks were made by Dr. Daniela Kaisth, Vice-President of Strategic Development of the Institute of International Education (IIE), and Mrs. Fanny Law, Delegation Leader. Ms. Ting Ting Li, Vice Consul, Consulate General of the People's Republic of China in New York, made a speech as Guest of Honour and the keynote address was given by Ms. Helena Kolenda, Programme Office for Asia, The Henry Luce Foundation Trustee, The Lingnan Foundation. During the weeklong programme, the 30 delegates visited The United Nations, Bloomberg Communications, Harlem's Striver's Row, Time Warner Center, Samsung Experience, BBDO, Roosevelt Island and Octagon Building. They also learned from eminent speakers such as Mr. Josh Kutticherry, Innovation Analyst, Futurethink, Ms. Robin White, Principal of Media Combo, Ms. Nikki Stelma, Brand Ambassador of The Samsung Experience, Mr. Sanjive Vaidya of Vaidya Stoltz Architects, and Mr. Diiorio Matt of BBDO and explored the application of innovative ideas in Urban Technology and Environment and in media and entertainment business.



3. "A Night At The Pawn" Charity Dinner

"A Night At The Pawn" Charity Dinner was held on 14 of June 2008. Held in a revitalised pawn shop, the restaurant has attracted much public attention.

The Organizing Committee was co-chaired by Mr. Bunny Chan and Mrs. Nina Lam and was made up of new members of our Programme and Fund Raising Committee with a group of young leaders who volunteered and have demonstrated their ability to lead. And of course, a very special thanks to Ms. Shelley Lee, Dr. Rosanna Wong, and the entire Programme and Fund Raising Committee for all their efforts. The event succeeded in raising \$1,012,811 for future activities. We were very honoured by the presence of The Hon. Mrs. Carrie Lam as our Guest of Honour, many friends and other senior community leaders.



4. The DragoNation

To connect the worldwide network which has been created over the past ten years, the Alumni Association of The Dragon Foundation was officiated on 30 May 2008 in the presence of Directors, Sir T.L. Yang, and Ms. Shelley Lee. Called "DragoNation", the Alumni Association is led by a core committee with representative alumni from different years and programmes, with the mission of maintaining a sustainable network of Foundation alumni to encourage service to the community, strengthen youth training, promote Foundation activities and recognize the contribution of outstanding Chinese youth.

To network members and to serve the community are the key foci of the Association. "DragoNation" has supported events of the Foundation including "A Night at the Pawn Charity Dinner", the 2008 "Global Citizenship Programme", "Dragon 100 Young Chinese Leaders Forum 2008," a series of film screening to local youth and The Hong Kong Federation of Youth Groups Flag Day.

It also initiated a range of community services including the "Dragons in Action" project, starting since November 2008. The launching included a film screening on poverty called "All's Right with the World". "DragoNation" helped organize community visits to low-income areas like Wan Chai and Sham Shui Po. It also promoted mentoring between alumni mentors and local secondary students through the "Young Dragon Programme". Volunteer were recruited for the 2008 Olympic Equestrian Games and the 2009 East Asian Games in Hong Kong. This community participation project also promoted and supported local artists through the co-organization of the "Uncle Kit Cut & Tear Art Exhibition" at Innocentre in early 2009. Other activities and events include regular Dragon gatherings, training classes, participation in community exchange and fund-raising events, and a quarterly issue of e-newsletter of Dragon alumni.

5. The Hong Kong Melody Makers

Founded by The Hong Kong Federation of Youth Groups with sponsorship from The Dragon Foundation, The Hong Kong Melody Makers (HKMM) was launched in 2005 and is dedicated to provide an outlet to a genre of music not readily available in Hong Kong. By so doing, the group also aims to give voice to the city's cosmopolitan spirit and to enrich Hong Kong's cultural life.

The HKMM participated in numerous, musical activities and social services. These activities included events organised by the Federation, a performance at the Hong Kong Cultural Centre Foyer Concert, the 2008 New Year's Eve Countdown Carnival and the Healthy Living Sharing and Variety Show cum Healthy Star Awards Ceremony, all by invitation of various government departments.

The highlight of the year's programmes was participation with different overseas *a cappella* groups in the 2008 a cappella in Town Concerts and the 2009 a cappella Festival. The HKMM shared the stage with such distinguished performers as the Jabberwocks (from the USA), the Harvard Dins & Tonics (USA), Vocaldente (Germany), Klangbezirk (Germany), Takarabune (Japan), Mr. Kaichiro Kitamura (Japan) and the Popphone Singers (Taiwan). They also had their own concern ton 31 March 2009 at the Cultural Activities Hall of the Shatin Town Hall as a finale to the Festival.

They also sang at the Commissioning Ceremony of the Foundation's Global Citizenship Programme in June 2008.

6. Hong Kong Design Week 2008/09

The Foundation supported the Education Corner Creative Workshop of The Hong Kong Design Week 2008/09. The workshop was held for four consecutive days at the Inno Design Tech Expo (IDT Expo), Hong Kong Design Centre exhibition area. A series of Creative Workshops aimed at increasing youth interest and participation in design and creativity. During the workshop, 831 students from 48 schools were given the opportunity to explore their design and creative talents. Completed works were exhibited at the exhibition hall.

Students gained inspiration through interaction with various creative media and the guided tour at Inspiration Hall. They were also able to put into practice and develop their creativity exhibiting through the support of instructors and on-site staff. Each workshop was lead by HK Design Institute (HKDI) and School of Design (SD) of Hong Kong Polytechnic University separately.
