## Agreement

- 1. Delegates are required to participate in the whole programme from 27 July to 3 August 2019 inclusive. Delegates are required to register at the Harbour Plaza Hotel North Point in Hong Kong on or before 5 p.m. (HKT) on 27 July 2019 and follow the full programme schedule thereafter.
- 2. The following personal information of the delegates will be published in the delegation booklet: English and Chinese names, photo, nominating country/region, nominating organisation, academic background, current occupation and short essay.
- 3. Each delegate will be assigned to a group with other delegates. Unless otherwise specified, delegates must always travel with their own group.
- 4. Delegates should follow the instructions of programme staff and their group coordinators.
- 5. All activities in the programme are obligatory and delegates must complete the programme assignments during and after the trip.
- 6. Consumption of alcohol and smoking are NOT allowed during the whole programme.
- 7. Mobile phones and audible devices must be switched to silent mode during all programme activities.
- 8. Delegates must sleep in their assigned hotel rooms.
- 9. Delegates are responsible for their own personal belongings. The Dragon Foundation makes no warranties of any sort concerning the security of delegates' possessions.
- 10. Compensation for damage made by any delegate is at the responsibility of the delegate.
- 11. Delegates should attend media interviews and other PR functions arranged by the organiser.
- 12. Anything that any delegate does must abide by the laws of HKSAR and China.
- 13. Certain risks are associated with all travels, including but not limited to natural disasters, infectious disease outbreaks, transportation accidents and possible terrorist activities. Delegates should understand and acknowledge that they assume all risks incurred by their participation in the Programme.
- 14. Delegates must be ethnic Chinese.
- 15. If any delegate is found in breach of these guidelines and requirements during the Programme, he/she may be dismissed from further participation and The Dragon Foundation will incur no liabilities. The delegate must reimburse the organisers for all costs incurred.
- 16. The Registration fee paid is non-refundable and non-transferrable. Delegates who fail to pay the fees by the specified deadline will be regarded as having declined the offer.
- 17. Any delegate who withdraws on or after 15 July 2019, agree to pay all costs already incurred by the organisers for your participation (e.g. transportation, meal and lodging expenses).
