## Dragon 100 「龍匯 100」 2024

### Agreement

*(This Agreement is only available in English)*

1. Delegates are required to participate in the whole programme from 3 August to 10 August 2024. Delegates are required to register at the designated hotel on or before 3 p.m. (HKT) on 3 August and follow the full programme schedule thereafter.
2. The following personal information of the delegates will be published in the delegation booklet: name, photo, nominating country/region, nominating organisation, academic background, current occupation and 150 words in English or Chinese about his/her ideas on the topic of “**The Value of Traditional Culture in Modern Society** (傳統文化於現代社會的價值)”.
3. Each delegate will be assigned to a group of delegates. Unless otherwise specified, delegates must always travel with their own group.
4. Delegates should follow the instructions of their Group Coordinators and Programme staff.
5. All activities in the programme are obligatory, delegates must complete the programme assignments during and after the trip.
6. Consumption of alcohol and smoking are NOT allowed during the whole programme.
7. Mobile phones and audible devices must be switched to silent mode during all programme activities.
8. The Dragon Foundation will arrange for two delegates in a double room. Delegates must sleep in their assigned rooms. If any delegate needs to change to a single room, the additional room price must be paid by the delegate.
9. Delegates are responsible for their own personal belongings. The Dragon Foundation makes no warranties of any sort concerning the security of delegates’ possessions.
10. Compensation for damage made by any delegate is at the responsibility of the delegate.
11. Delegates should attend media interviews and other PR functions arranged by the organisers.
12. Anything that any delegate does must abide by the law of HKSAR and Mainland China.
13. Certain risks are associated with all travels, including but not limited to natural disasters, infectious disease outbreaks, transportation accidents and possible terrorist activities. Delegates should understand and acknowledge that they assume all risks incurred by their participation in the Programme.
14. Delegates must be ethnic Chinese.
15. If any delegate is found in breach of these guidelines and requirements during the Programme, he/she may be dismissed from further participation and The Dragon Foundation will incur no liabilities. The delegate must reimburse the organisers for all costs incurred.
16. The Participation Fee paid is non-refundable and non-transferrable. Delegates who fail to pay the fees by the specified deadline will be regarded as having declined the offer.
17. Any delegate who withdraws on or after 3 July 2024, agree to pay all costs already incurred by the organisers for your participation (e.g. transportation, meal and lodging expenses).

As a delegate of the Dragon 100 2024, I fully release The Dragon Foundation (including, but not limited to, its trustees, employees and representatives), from any responsibility and from any demands, claims, actions, suits, damages, losses, liabilities, costs and expenses (including, but not limited to, court costs and attorneys' fees) and covenant not to sue for any cause whatsoever directly or indirectly arising in connection with my participation in the Programme, whether or not foreseeable or contributed to by the negligent acts or omissions of The Dragon Foundation.
